

- 1. The promoter is Elders Rural Services Australia Limited (ABN 72 004 045 121) (**Elders**) of Level 10, 80 Grenfell Street, Adelaide, SA 5000.
- 2. Elders' \$25k Your Way Promotion (the **Promotion**) commences at 12:00am ACST on Monday, 29 July 2024 and closes at 11:59pm ACST on Friday, 31 October 2024 (the **Promotion Period**).
- 3. To be eligible to enter the Promotion, you must:
 - 3.1. reside in Australia;
 - 3.2. be 18 years or over; and
 - 3.3. accept and comply with these Terms and Conditions.
- 4. You will automatically receive one (1) entry into the Promotion if:
 - 4.1. you are the owner of a property situated in Australia (the **Property**);

- 13. Elders' decisions in relation to the Promotion, including your eligibility to enter the Promotion and the drawing process are final and Elders is not obliged to correspond with you in relation to these matters.
- 14. Elders, each Franchisee and their related bodies corporate and their respective officers, employees, agents and contractors are not responsible for:
 - 14.1. lost, illegible, misdirected, incomplete or damaged entries;
 - 14.2. incorrect or inaccurate transcription of information, human error, technical malfunctions or delayed entries;
 - 14.3. the failure to conduct an Appraisal during the Promotion Period.
- 15. Elders or the Franchisee (as applicable) reserves the right to refuse to undertake an Appraisal at its sole discretion.
- 16. To the extent permitted by law, Elders excludes all:
 - 16.1. liability to you for any loss, damage, claim or expense that you suffer or incur in connection with this Promotion and the Prize; and

- 16.2. warranties, representations or guarantees (**Warranties**) regarding the Promotion and the Prize, including any Warranties which may have been made in the course of advertising or promoting the Promotion.
- 17. You release Elders, each Franchisee and their related bodies corporate from any liability, cost, damage or expense arising out of, or in connection with, the Promotion and the Prize.
- 18. You indemnify Elders, each Franchisee and their related bodies corporate against all claims, costs, liabilities, losses and expenses which Elders or its related bodies corporate pays, suffers, incurs or is liable for arising out of or in connection with your breach of these Terms and Conditions.
- 19. By participating in this Promotion, you acknowledge, consent and agree that Elders and each Franchisee (where applicable):
 - 19.1. will collect and use your personal information in order to conduct the Promotion;
 - 19.2. may disclose your personal information to its related bodies corporate, officers, employees, agents or contractors in order to conduct the Promotion; and
 - 19.3. may use your personal information for future promotional, marketing and publicity purposes unless otherwise directed by you in writing.

- 21. Subject to any law or regulation to the contrary, Elders reserves the right to substitute the Prize for an alternative of the same or greater value if (after making reasonable attempts) it fails to reach mutual agreement with the winner in relation to a substitute.
- 22. If for any reason this Promotion is not capable of running as planned, and subject to regulatory approval, Elders reserves the right in its sole discretion to cancel, terminate, modify or suspend the Promotion.
